



ALTERNATIVES TO IRRIGATION VIOLATION FINES

The City provides two (2) alternatives to paying \$50.00 for an irrigation violation fine. These fine alternatives are available to first-time violations only. If you have received subsequent violation notices (e.g. second, third, fourth, etc.), you are not eligible and a fine will be assessed to your utility bill.

In lieu of paying the \$50.00 fine, select either **Alternative A** or **Alternative B**, and follow the associated instructions below.

ALTERNATIVE A

View one (1) of the following videos, modules, or tutorials and complete and pass the corresponding test. Tests must achieve a passing score of at least 70% in order to qualify as an alternative to the \$50.00 fine. You have 3 chances to pass any test, but there are only 30 days total to submit a passing test. If you do not pass the third test, a \$50.00 fine will be added to your water utility bill.

ALTERNATIVE B

Attend one (1) Florida Friendly Landscaping™ Workshop within thirty (30) days of your receipt of an irrigation violation notice and submit the Verification of Attendance Form to the City of Winter Garden’s Water Conservation Coordinator. Florida-Friendly Landscaping™ workshops are presented by UF/IFAS Florida Yards & Neighborhoods staff and are held at various locations and times around the State of Florida. If you do not submit a passing test or the Verification of Attendance Form within 30 days of your initial violation notice, a \$50.00 fine will be assessed to your Winter Garden Utility Bill. Electing either of these alternatives does not preclude you from receiving irrigation violation notices if subsequent violations are committed.
